("Cosmelux" or the "Company"), a global leader in lacquering and UV metallization for the cosmetics packaging market. The Company's founders, the Zorloni family, will retain a 30% ownership stake and maintain a management role at Cosmelux. Capital Dynamics, an independent global private asset management firm, participated in the transaction via the mid-market investment program of its long-established private equity co-investment business.

"Cosmelux is a resilient Italian business with an impressive customer base and a talented, dedicated staff," said Andrea Mugnai, Founder and Managing Partner at PM & Partners. "We are looking forward to working with the Zorloni family and Capital Dynamics on an ambitious growth and development plan, which includes entering new market segments and geographies in the cosmetics industry and complementary markets."

Cosmelux is the second investment concluded by PM&Partners III Fund which is at an advanced stage of fund-raising.
